To that end, the Co-op takes its carbon footprint very seriously. As evidenced by the fact that members are rewarded for bringing their own bags, while those who require a paper bag are fined a nickel. Taking this earth-first pledge a step further, the Davis Food Co-op has made a habit of embracing high-efficiency technology with custom solutions provided by the EnergySmart Grocer Program.

Since 2002, EnergySmart Grocer has worked to assist grocers in lowering their operating costs and energy consumption through highefficiency upgrades. Davis Food Co-op was there from the start, and continues to receive regular energy audits from the program.

# **Cool Under Pressure**

The main focus of an EnergySmart Grocer energy audit is to pinpoint areas where significant energy savings are ripe for the picking. More often than not, those savings come courtesy of energy-efficient refrigeration retrofits. During the Davis Food Co-op's most recent audit, EnergySmart Grocer made the recommendation to replace the floating head pressure and floating suction pressure controls. These changes paid immediate dividends, as the store saw a four percent drop in energy costs in the first quarter after installation.

## The Big Payback

Over the years, the Co-op has teamed with EnergySmart Grocer to implement a wide variety of energy-saving upgrades.

### Examples include:

- Anti-sweat heater controls
- Case lighting T8 and LED with motion sensors
- High-efficiency low temp reach-in cases
- High-efficiency medium temp open cases
- Case EC motors
- Night covers
- Strip curtains

Thanks to its most recent upgrades, made with the guidance of EnergySmart Grocer, the Davis Food Co-op anticipates saving an extra 135,532 kWh in 2011 alone. Those savings pay off not just in the form of lower utility bills, but also by reducing the store's environmental impact. For Davis Food Co-op, a store founded on the idea of doing things the right way, that's a benefit that can not be undervalued.
